CHANGE OF CHINESE NAME FOR IDENTIFICATION PURPOSE

The board (the “**Board**”) of directors (the “**Directors**”) of Zero2IPO Holdings Inc. (the “**Company**”) hereby announces that with effect from September 17, 2025, the Chinese name of the Company, which is used for identification purpose only, will be changed from “清科創業控股有限公司” to “清科控股有限公司” (the “**Change of Chinese Name**”). The English name of the Company will remain unchanged as “Zero2IPO Holdings Inc.”.

EFFECTS OF THE CHANGE OF CHINESE NAME

The Change of Chinese Name will not affect any rights of the shareholders of the Company. The Chinese name of the Company is used for identification purpose only and share certificates of the Company do not bear its Chinese name. All existing share certificates in issue bearing the English name of the Company will, upon the Change of Chinese Name becoming effective, continue to be evidence of title to the shares of the Company and valid for trading, settlement, registration and delivery purposes. As shareholders do not need to return their existing share certificates, there will be no arrangement for any exchange of existing share certificates.

CHANGE OF CHINESE STOCK SHORT NAME

With effect from 9:00 a.m. on September 17, 2025, the Chinese stock short name of the Company will be changed from “清科創業” to “清科控股” for trading in the shares of the Company on the main board of The Stock Exchange of Hong Kong Limited. The English stock short name of the Company of “ZERO2IPO”, and the stock code of the Company of “1945” remain unchanged.

CHANGE OF COMPANY LOGO

With effect from September 17, 2025, the logo of the Company will be changed to reflect the Change of Chinese name. The existing logo and new logo of the Company are set out below for identification purpose:
